



2024 SUPPLEMENTAL TAX INFORMATION

All distributions made on non-retirement accounts by the Fund in 2024 are reported to you on IRS Form 1099-DIV. If you have proceeds from transactions in your non-retirement account, they are reported on IRS Form 1099-B.

Tax Treatment of Distributions: The federal income tax treatment of dividends and capital gain distributions is the same whether you chose to reinvest or receive payments in cash. All income dividends and capital gain distributions are reported to the Internal Revenue Service as required by law. For taxable accounts, all income dividends and capital gain distributions must be reported by shareholders for income tax purposes.
